# DRAFT ISSUES: TEXAS LEGISLATURE 2025

# Fire And Police Retiree Health Care Fund, San Antonio

# I. <u>Substantive Changes</u>:

(the "Act" is the governing state statute found in Art. 6243q; the "Retiree Health Plan" is the Board approved plan setting out benefits and requirements.)

# A. Obligation of the Pension Fund to Collect Contributions Post-Retirement

The Act requires retirees who retire with less than 30 years of service (and their surviving spouses, if applicable) to continue making contributions until (i) the retiree becomes or would have become eligible for Medicare coverage, or (ii) the 30-year level of contributions are made. The Pension Fund is required by the Act to deduct those contributions from annuity payments made by the Pension Fund. [Section 4.02 (c), (d)]

The recommendation is to remove the requirement that the Pension Fund make the deductions. Instead, the obligation to make the contributions would rest with the retirees/surviving spouses as facilitated by the Health Care Fund, and the contribution for each month must be made by the last day of that month, commencing on the first month following the month in which the retiree retires. Contributions not made in a timely manner would bear interest at the Health Fund's actuarial rate of return then in effect.

# B. Benefits for Widows who Remarry after Retirement

It is our understanding that some retirees have expressed concern over the requirement that widows of retirees who remarry then become ineligible for coverage under the Retiree Health Plan. That provision is not set out in the Act, but rather in the Retiree Health Plan. The Act provides that the Retiree Health Plan may be amended by the Board so long as the Health Fund's total actuarial unfunded liability is not thereby increased. The recommendation is to amend the Act to give the Board specific authority to amend the Retiree Health Plan to address the remarriage issue regardless of the effect on the actuarial unfunded liability, thereby allowing widows who remarry to continue to receive benefits subject to certain conditions.

# C. Members who are Married Couples

The Act requires that members who are married must each make contributions to the Health Fund while they are active, and, if necessary to satisfy the 30 years of service contribution requirement, post-retirement. [Section 4.02 (a)] The recommendation is as follows: (i) for as long as either spouse is an active member, that spouse will be required to continue to make contributions, (ii) upon the retirement of the *first* spouse to retire (Spouse A), Spouse A may elect to become covered under Spouse B's health insurance with the City, and if such election is

made, Spouse A's obligation to make post-retirement contributions for purposes of satisfying the 30 years of service contribution requirement will be suspended, and (iii) if Spouse A and Spouse B become divorced following Spouse A's retirement, Spouse A's obligation to make contributions to the Fund will resume, beginning in the first month following the month in which the divorce occurs, at the then-current contribution level.

# II. Clean-up Changes

# A. Retiree Health Plan Coverage of Dependent Children

The Plan currently provides for health coverage for dependent children, subject to certain conditions. The recommendation is to clarify that the Board has authority to set a premium for the coverage.

# B. Division of Benefits Upon Divorce

The recommendation is to specifically set out in the Act that benefits payable by the Health Fund do not constitute property divisible upon divorce.

# C. Waiver of Right to Receive Benefits

The Act does not specifically provide that a member or other beneficiary may waive his or her rights to receive benefits under the Act post-retirement. The recommendation is to amend the Act to include such a provision. The option will only be available to retirees and dependents.
