At 10:03 a.m., Chair Despres called the meeting to order. Chair Despres administered the oath of office to Councilmembers Havrda and Andrews-Sullivan. The roll was called, and a quorum was declared present. The minutes from the meeting held on July 29, 2019 were reviewed and unanimously approved upon motion by Trustee Trevino and second by Trustee Perez.

EXECUTIVE

SESSION:

<u>Executive Session</u>: The Board adjourned into Executive Session at 11:05 a.m. pursuant to state law to discuss with counsel legal issues relating to real estate issues. The Executive Session adjourned at 11:46 a.m.

ACTION ITEMS:

1. <u>Investments</u>: Mr. Bounds briefed the Board on a recommendation from the Investment Committee to make a \$10 Million investment in Portfolio Advisors Credit Strategies Fund ("open ended" private debt). Upon motion by Trustee Silliman and second by Trustee Perez, the \$10 Million investment with Portfolio Advisors was unanimously approved effective October 1, 2019.

- 2. <u>Personnel/ Audit</u>: Mr. Bounds reported that the audit is substantially completed and will be presented at September meeting.
- 3. <u>Benefits:</u> Ms. Puga reported on update of APH software (patient's histories) which should be completed shortly.
- 4. <u>Legislative</u>: Mr. Burney provided the Board a summary of 2019 legislation passed by the Texas Legislature that may affect the Health Fund.

5. <u>Administrative Report</u>:

- a. <u>Expenses:</u> Mr. Bounds presented the expenditures for the Fund. Upon motion by Trustee Perez and second by Trustee Havrda, a list of expenses and claims and the Financial Report were unanimously approved by the Board.
- b. <u>Elections</u>: Mr. Bounds presented the election schedule for 2019.
- c. <u>Contribution Increase</u>: Mr. Fenlaw and Mr. Bounds briefed the Board on contribution increases for COSA and active members effective September 1, 2019. Upon motion by Trustee Perez and second by Trustee Andrews-Sullivan, the Board unanimously approved the contribution increases.
- d. Third Clinic: Mr. Bounds briefed the Board on the due diligence and search for location for a third clinic in the Northwest quadrant of San Antonio. Upon motion by Trustee Silliman and second by Trustee Andrews-Sullivan, the Board unanimously authorized Mr. Bounds to negotiate, engage, and execute a broker agreement and a contract to acquire the location at 9018 Culebra Road. Health-by-Design recommends approval of this property.

6. <u>Consultant Report</u>:

- b. <u>Actuarial</u>: Mr. Fenlaw presented recommended assumptions for the January 1, 2019 actuarial valuation. Upon motion by Trustee Trevino and second by Trustee Havrda, the Board unanimously approved the assumptions.
